

# **Skill Set Requirements**

Successful completion of 1 unit of competency:

• CPCWHS1001 Prepare to work safely in the construction industry

### Description

WHS General Induction for Construction is also known as White Card training. Current workplace health & safety (WHS) legislation requires all employees that either work in the construction industry, or enter any building or construction site, to be trained in workplace health and safety (WHS) in the workplace and hold a valid white card, or industry equivalent.

Upon successful completion of the course you will be issued with a SafeWork NSW Statement of Training which allows you to work in the Construction Industry immediately.

### **Recommended Target Audience**

Workers who need to hold a White Card to work on a construction site throughout Australia. Minimum age of participants is 14 years old at the time of registration.

#### Enrolment

Participants will be required to complete a booking form prior to training. On this form participants can indicate whether they require further assistance due to any LLN issues. This is most important so that the trainer/assessor can implement any processes prior to the day's training.

### **Pathways Information**

This unit provides a credit towards many difference construction industry qualifications.

### **Statement of Attainment**

TMT Training will have the application forms you need for a new White Card and will submit them to SafeWork on your behalf when you have completed the training. The fee for lodgement is included in your course fees.

TMT Training will also give you a statement of attainment that you can use to prove you have completed the training until your new card arrives. This unit of competency meets industry requirements to allow workers who want to carry out construction work in NSW.

### **Delivery and Assessment Method**

Theory assessment – multiple choice/short answer questions.

Practical assessment - work activities performed throughout the elements of the unit in group discussions and workplace scenarios. These activities provide the evidence needed by the trainer to grant each participant competency in the required elements.



The following must be present and available to learners during assessment activities:

- Equipment
  - o Demonstrate the fitting of all of the PPE listed in the performance evidence
- Specifications -
  - State or territory Act relevant to the location of the learner, as specified in the range of conditions.

The assessment of performance evidence must be done by direct observation of the learner by an assessor, either by an assessor observing the learner physically and/or by an assessor observing the learner via audio and visual media in real time.

- ✓ Identify health and safety legislative requirements of construction work
- ✓ Identify construction hazards and risk control measures
- ✓ Identify health and safety communication and reporting processes
- ✓ Identify incident and emergency response procedures

## Prerequisites
